1935 Silver Jubilee of King George V List of Common Design Printers and the Varieties

Printers

Printing for the common design stamps was undertaken by three companies. Waterlow & Sons prepared the master dies of the vignette and frames. Duplicates were provided to the other two printers. This accounts for the differences in varieties seen. Perforation size for the Waterlow and Bradbury printings were 11 x 12 whereas the De la Rue perforations were 13 1/2 x 14. The De la Rue printings contained the vignette plate numbers on the bottom selvages (margins) under the fifth stamp in the bottom row. Although these were not present with the other printers the various plates have been identified. Bradbury and Waterlow undertook the printing for 15 colonies each (see below), while De la Rue did the printing for 14 colonies.

Bradbury Wilkinson & Co. - Plate 8 Varieties

Plate 8 apparently exists in two states. Plate **8A** is the first state and has the hairline marks in column 5. It exists on the Gilbert & Ellice Islands, Falkland Islands, Hong Kong and all other colonies printed early. Plate **8B** is the corrected plate where the hairline mark has been removed and occurs with later printings. An additional flaw 9/2 occurred with these printings. Some stamps show both hairline marks and varieties. These have been designated as "Common to both Plates 8" suggesting that these flaws were on all printings of these stamps.
